III. Old Business

IV. <u>New Business</u>

- **A.** Suggested business meeting alternatives
 - 1. Suggestion one: Board meetings held to discuss most of business we have been taking care of in our regular meetings. Could be held before regular meetings/another day. Everyone still welcome at board meetings so if anyone wanted to be a part of the decision making process they could attend the board meetings. Agenda could be sent out to all members so everyone would know what was being discussed. If there is a matter that the general membership needs to have a say in, it could be handled in a brief business session during our regular meeting. If the business of the chapter is conducted in that manner the business part of the regular meeting should take no more than 15 or 20 minutes. Bruce Neville said a previous attendee came to a meeting for an hour and left because the speaker didn't arrive when she thought, i.e. at the beginning.
 - 2. Suggestion two: Change order of our meetings. Have speaker first and business meeting after refreshments. Speakers generally like to come early to set up equipment and then they have to sit around for an hour while we have our business meeting and 30 more minutes for refreshments. If they were to speak first the speaker could join us for refreshments, if he/she so chose, and answer member's questions or respond to comments during that time instead of having to extend the length of the meeting. Jim Anding suggested the speaker first, then snacks, and finally short meeting. Jo Anne Bates suggested separate board meetings. Jean Paul said we don't want to lose the public because they're invited. Jo Anne Bates moved to have board meetings when the president chooses and just have a short business meeting before each month's meeting. Board meetings open to all BVTMN. Seconded by Bruce Neville.
