## III. New Business

**A.** Volunteer hour discussion-Sarah Laughlin: It's been noted our hours are not coming from projects but from food. Bringing food as volunteer hours is not in line with our organization's mission. Board agrees they have no problem removing it. Volunteer hours should be coming from working with nature. But we have some projects coming up that will give volunteer hours working outside, such as working with greenways, working with monarch butterflies, and others.

- Ebirding data entry only will count for hours, not the birding itself (unless it is for a survey). As of November 13, 2014, the chapter will no longer accept or approve submitted volunteer hours for bringing food or birding. Betty is waiting to hear back from Michelle Haggerty as to whether or not this will be retroactive and if so, when in 2014 the hours will be removed from credit.
- **B.** Dues discussion-Sarah Laughlin. Amanda C: propose to raise our membership fee to \$25 for a single person and \$40 for a couple. Amanda can do an end-of-year report that will show what each committee has spent, except for those that have said they have expenses for reimbursement but have not submitted them. She will email Jan 1 to Dec 31 account year-in-report to Board. She will give a deadline of the social to have all reimbursement requests submitted in order to be able to have an accurate report. Preliminary report to committee chairs first for approval and then to Board. End-of-year report and January 2015 budget will be sent to officers plus chairs. Bruce moved to tabled tentative dues increase until review of budget. In spring 2015, Board will look at numbers to make a decision for 2016.
