#### **HEB Pollinators for Texas project Info - important to know!**

Catherine and Patsy outlined how to record volunteer hours for the HEB Pollinators for Texas grant project at the meeting last night. For those who weren't there, I have attached the instructions. I highlighted what is of relevance, also.

There are actually four categories to report hours to for this event. The first one is field research hours which involves dissemination of information either by media or directly to other people. The second is NPA, which involves improving the area for humans. The third is NRM which involves improving the area for Pollinators and other living things. The fourth is "Training others," which will not apply to most members. Catherine and Patsy are doing the training. The documents with examples of what qualifies in each of the first three categories are attached.

Reporting hours is very important for this project. If you donate native plants from your place to the Wildscape report the time you spent gathering the plants and preparing them to be replanted and report that as an "NRM" event (improving the area for animals

If you clear the paths through it, report it as "NPA" (improving the area for humans).


If you take photos of Pollinators at the Wildscape and post them on a blog and/or iNaturalist, report all the time spent doing the photos and writing the blog, or posting on iNaturalist as "FR" (dissemination of info). If you post a blog and post on iNaturalist record the time posting on iNaturalist separately and include in the notes "HEB Pollinators for Texas" project.

I've listed links below for our very own Bioblitz on iNaturalist for the HEB Pollinators for Texas project. If you join the bioblitz, your post photos from the area of the Wildscape will automatically be posted to our bioblitz.

I've also listed the link for the statewide bioblitz on Pollinators. You can take photos anywhere in the state for this. Your posts will go automatically to the bioblitz if you "Join" it. Count time spent photographing, editing and posting the photos.

There is no official workday at the Wildscape this Saturday. They will be coming soon, but you can go out there and take photos and post or pull weeds or remove debris or reorganize the storage shed. Report those hours under the HEB Pollinators for Texas hours.

I hope this is helpful.
