Minutes of Meeting  
September 4, 2008  
Cotton Belt Building, Tyler, TX

The East Texas Chapter of Texas Master Naturalist met at the Cotton Belt Building in Tyler, TX on September 4, 2008 at 6:45 P.M. Sixteen members were present. The meeting was called to order by President, Richard LeTourneau.

Our Vice President, Clyde McKinney, introduced the speaker, Dr. Lynn Sherrod. He spoke about "The Asteraceae" (Sunflower/Daisy Family)

After the program there was a break for refreshments provided by Clyde McKinney.

The minutes of the April meeting were read and a motion was made by Ann Reynolds and seconded by Don Gibson that the minutes be approved as read. Motion carried.

Due to the absence of the treasurer, there was no treasurer's report given. The president stated that the balance in the account is around \$2400.00.

It was announced that the next chapter meeting will be on Thursday, Oct. 2, 2008 and we will not have a regular meeting in November.
