#### Call to Order

President Wanda Rauscher called the meeting to order at 5:37 pm.

#### President's Update – Wanda Rauscher

Events that ETCMN participated in since January include: Great Texas Birding Classic, Texas Prairie Dawn Count on Earth Day, April Chapter meeting with Dr. Neil Ford, City Nature Challenge, Camp Tyler A-maz-ing Adventure, May Chapter meeting field trip to Tyler State Park with Jeff Sparks, East Texas Fire and Nature Festival, Fairfield Library Dragonflies/Damselflies Presentation, Tyler's Bee Day in the Garden, June Chapter meeting with Jessica Coleman, July Chapter meeting with Sam Stone and Odolympics. Also, Caryn Vorsas represented our chapter at the Rose City Farmers Market. She had a pollinator display and thaumatropes for the children.

State TMN received a grant from Texans by Nature. This grant will provide tailored support to develop a strategic plan for guiding TMN's next 25 years. This plan is essential to sustaining the program's momentum and addressing the increasingly complex conservation challenges facing Texas. Part of the process will be survey to: First: Chapter Presidents and Immediate Past Presidents, Second and third: Active and Inactive members in the VMS, Fourth: Chapter Partner Organizations, Final: Agency State Sponsors with direct oversight of the TMN program.

#### 2025 New Training Class - Kay Jenkins

Fifteen people signed up for the new training class and two dropped out. Nine completed the training, and three of the four are almost finished. One trainee is 4.25 hours away of becoming certified. One trainee from the fall 2024 class completed initial training during the spring 2025 class.

There will be a spring 2026 class with Wanda serving as co-training director. The application form, information page and flyer have been updated and will be uploaded to the website upon approval. One member from the 2024 class and one from 2025 have offered to teach units. Two people have expressed interest in attending the 2026 class.

#### **Membership – Donna Smith**

Recertification and Milestone Awards include: one member 2025 recertification, six members 2025 recertification, 250 Hour Service Pin – two members, 500 Hour Service Pin – one member and 1000 Hour Service Pin. There have been five transfer members for 2025 so far.

#### **Volunteer Management System – Lindsey Smith**

Second quarter (April, May, June) had 3016 volunteer service hours reported by 67 active chapter members which represents \$69,368 given to the state's endowment by the federal government's Pittman-Robertson Wildlife Fund. During that same time there were 392 advanced training hours entered in VMS. Year-to-date ETCMN has contributed 7,543 volunteer service hours by 78 active chapter members resulting in \$173,489 going to the state's endowment. There have also been 1,273 advanced training hours enter into the VMS so far.

As the 25<sup>th</sup> chapter anniversary approaches, it is interesting to note that there have been 319 both active plus inactive members that have contributed 91,033 volunteer service hour from January 2000 – August 2025 resulting in \$2,093,759 toward the endowment fund. These members received 13,273 hours in advanced training as well.

The state is changing the VMS database so that active members are at the chapter level. Inactive members will still be retained at the state level in the archives.

#### Texas Prairie Dawn Count on Earth Day (April 22) 2025

We had seven from East Texas Chapter TMN (Jan Barth, Meleena Byram, Dawn Bahr, Lance Homeniuk, Pat Howarth, Wanda Rauscher & son Jonathan) and 2 additional volunteers from Cypress Basin Chapter TMN to perform the plant count for the Texas Prairie Dawn Flower, a rare plant endemic to East Texas that is on the endangered species list. Jan

Culverson, US Fish and Wildlife, requested our assistance. The natural habitat for the Texas Prairie Dawn Flower (*Hymenoxys texana*) is a river terrace with salty sandy soils that have not been plowed before, which is rare in any part of Texas. The area we visited is on property that belongs to Komatsu Mining Corporation in Gregg County along Grace Creek

We counted 6,845 plants (where at least one plant was in the quadrat). We counted plants in 291 quadrats (0.25 square meter size) over the whole area surveyed = 72.75 square meter area (size of patch). That means there were approximately 23 plants in each quadrat (that had at least one plant) or 94 plants per square meter. We looked for plants in grids where grasses were growing and, in most cases, there were no plants or just one because there was too much competition from other plants/grasses. Those zero quadrats were not included in this density estimate. Jan Culverson used the density estimates to determine the overall count for the rest of the flowers on site.

#### **April 24 Chapter Meeting**

Dr. Neil Ford, Professor Emeritus in the Department of Biology UT Tyler talked to us about the snake species found in East Texas.

**City Nature Challenge 2025** -(observations April 25-April 28 with identifications through May 4). This was the 10<sup>th</sup> year for City Nature Challenge and our 5<sup>th</sup> year as a participant. We had observations posted in every single county of the chapter catchment. Lindsey Smith led the walks at the Mineola Nature Preserve and Donna Smith, Polly Jones, and Allison Utley helped with outreach efforts at Mineola. Meleena Byram and Pat Howarth joined Wanda at Martin Creek Lake SP. We had a respectable showing with 3195 observations of 1019 different species made by 193 observers with 284 folks identifying.

Camp Tyler A-maz-ing Adventure May 12 &13, 2025 (roughly 200 students attended event) Cindy Smith worked with Wanda & then solo at the Camp Tyler A-maz-ing Adventure for the White House ISD 8<sup>th</sup> graders on May 12 &13! We used Pollinator Syndrome as a matching challenge for the teams. [Wanda spent the 13<sup>th</sup> at SFA with Kay Jenkins delivering a program for the Groveton 5<sup>th</sup> graders.]

May 22 Chapter Meeting was a FIELD TRIP. We gathered at the Blackjack Pavilion at Tyler State Park to hear Jeff Sparks tell us about recreating the Post Oak Savanah- a process that has taken years and requires ongoing effort to preserve!

**East Texas Fire and Nature Festival June 7**. Nineteen master naturalists came out to volunteer for the first ever East Texas Fire and Nature Festival: Amy Cumbie, Mark Edmund, Carol Lanthrum, Patty Gray, Cindy Harlan, Karen Rueb-Hall, Clay Beard, Becky Whisenant, Gail Bean, Vicki Hoppis, Ann Reynolds, Meleena Byram, Pat Howarth, Lance Homeniuk,

Dawn Bahr, Caryn Vorsas, Joe Vorsas, Dennis Minor, and Kay Jenkins. Kay was the mastermind behind the "Bird Activities" that were enjoyed by the big kids visiting our booth. Wanda provided the pollinator display that included the bee and flower thaumatrope craft for the younger set, the iNaturalist display, and the "What Does an East Texas Master Naturalist Do?" display. Lance kept count of our visitors. We had 63 adults and 66 kids visit our booth. Toni Aguilar reported just under 300 in attendance at the event. A number of folks suggested we should do this event again. I was impressed with how many kids were able to answer fire fest questions correctly by the end of the festival. Just so you know Kay and Carol spent some hours preparing the booth materials and Kay, with Dennis and I spent almost four hours getting canopies & floors & tables & supplies ready the afternoon before the event. A fellow master naturalist said if there was an award for best booth we surely would have won such. We did have guests from Cypress Basin Chapter TMN and North Texas Chapter TMN visit our booth. We WILL have a chance to do it again! Plans are in the works to do the Fire & Nature Festival Spring 2026.

#### Fairfield Library Dragonflies & Damselflies Presentation June 18

Wanda presented on odonates to the younger set at Fairfield library. Had 41 kids and 21 adults attending presentation & participating in a craft activity to decorate a wooden dragonfly.

Tyler's Bee Day in the Garden was June 21, 2025 at the Goodman-Legrand House & Museum grounds. We had a great pollinator display. For our kid activity we taught bee vision- they see orange but not red and see into the UV range where we can't. Participants made their own flower guide with invisible ink and then filled in the wildflower designs with colored pencils. When finished, the artists could view their masterpiece under a UV light and then add a bee sticker. Attendance was 71 adults and 61 kids. Big thank you to Ann Reynolds, Karen Rueb-Hall, and Dawn Bahr who worked with Wanda!

#### June 26 Chapter Meeting

Jessica Coleman, Senior Lecturer in the Department of Biology UT Tyler gave a talk entitled: "Look, Listen, and Learn: Birds and Habitats of East Texas". This presentation focused on four key habitats of our region—Pineywoods; Bottomland Hardwood Forests; Prairies; and Wetlands, Rivers, and Bayous. For each habitat, she shared insights on bird species, highlighting how to observe and identify them by sight and sound.

#### June 28 Rose City Farmers Market

Caryn Vorsas took pollinator display & thaumatropes to the Rose City Farmers' Market.

#### **July 24 Chapter Meeting**

Via ZOOM Sam Stone, Conservation Program Manager with the Texas Parks & Wildlife Foundation, talked about pocket prairies & pollinators, a future app in development, and issues in conservation for Texas.

#### **ODOLYMPICS Aug 16-24**

For Texas there were 2214 iNat observations of 96 species and in Odonata Central there were 337 records (for Texas).

#### **NEWS FROM STATE**

State TMN received a grant from Texans by Nature. This grant, the Conservation Wrangler, is an accelerator program that catalyzes the very best Texan-led conservation projects occurring in the state. Through the Conservation Wrangler program, the TMN Program will receive tailored support to develop a strategic plan, along with a sustainable strategic planning process that the TMN Program can utilize into the future.

"The program just celebrated our 25th Anniversary and, as we look towards the future, we recognize the need for a strategic plan that will serve as the foundation for guiding our next 25 years," said Mary Pearl Meuth, Texas Master Naturalist Program assistant program coordinator. "Developing a plan is essential to sustaining the program's momentum and addressing the increasingly complex conservation challenges facing Texas, and we're very fortunate and excited to collaborate with Texan by Nature."

I have had two people reach out to me saying they would like to attend the class. So, I'm hopeful that we won't have any trouble filling the slots.


#### East Texas Chapter Master Naturalist Program Now accepting applications for Spring 2026 Training

The East Texas Chapter of the Texas Master Naturalist Program is holding new member training for people over 18 years of age who are interested in becoming a Texas Master Naturalist. Training classes will begin January 20, 2026, and are tentatively scheduled to be held on eight Tuesday evenings (Jan 20 and 27, Feb 17 and 24, Mar 24, Apr 21 and 28, May 19) and six Saturdays (Jan 31, Feb 7 and 21, Mar 28, Apr 25, May 23), five of which will include field trips.



East Texas Chapter

The Texas Master Naturalist Program's mission is to develop a corps of well-informed volunteers to provide education, outreach, and service dedicated to the beneficial management of natural resources and natural areas within their communities for the State of Texas.



The program area of the East Texas Chapter includes Smith County and the nine surrounding counties. Communities and organizations in the program area, and adjacent areas where no active Master Naturalist Chapters exist, rely on trained citizen volunteers for implementing youth education programs; for assisting parks, nature centers, and natural areas; and for providing leadership in local natural resource conservation efforts.

Annual dues for membership in the East Texas Chapter are \$20 and are due in January of each year.

#### How to become a Texas Master Naturalist:

- Master Naturalist Trainees must successfully complete an approved training program with at least 40 hours of combined field and classroom instruction though a Texas Master Naturalist Chapter.
- While completing the training above, the candidate serves at least 40 hours of volunteer service in their community and engages in 8 hours of advanced training to advance their knowledge and connection with their ecoregion.
- In subsequent years, the candidate must complete another 8 hours of advanced training and donate 40 hours of volunteer service to maintain their certification (or to re-certify) as a Texas Master Naturalist.

The cost for the initial training program in the East Texas Chapter is \$150 and includes a hardbound copy of the *Texas Master Naturalist Curriculum* and entry fees to most field trip sites, if applicable. Trainees may purchase digital versions of the curriculum directly from Amazon (Kindle) or Google (Google Play) and reduce the training fee by \$50. # 2<sup>nd</sup> Quarter Report for VMS East Texas Chapter of Master Naturalists

During this same time, there were 392 advanced training hours entered in VMS.

As we approach our 25<sup>th</sup> anniversary for our chapter, it's interesting to note that we have had 319 both active plus inactive members that have contributed 91,033 volunteer service hours from January 2000, through August 2025, to the state's master naturalist program resulting in \$2,093,759. These members also received advanced training totaling 13,273 hours to help make us better volunteers!

#### East Texas Chapter Master Naturalists Communication Support: Website August 28, 2025

Since the last board meeting, we have had one glitch with the website. Over June and July, I was unable to post any events, and the calendar on our website fell behind schedule. This was due to the AgriLife web team noting some issues with site performance and the event calendar across the sites. There were some memory limitations on the network that were used to store large amounts of legacy data and old plugins. Due to this, we had to complete a Chapter Website Survey that focused on our use of the WordPress Template and platform. I completed the survey in mid-July. The AgriLife FirstCall Ticket I submitted for our issue with the website was resolved on July 25, 2025. All events were updated and back working by July 27<sup>th,</sup> and I am working to maintain our events as they are revised via the newsletters and Eblasts.
