
#### Who owns Wildlife?

#### Magna Carta - 1215

- Royal authority and ownership
- Forests, waterways, fisheries, and wildlife

#### **Colonial Ordinance - 1647**

- Government authority & oversight
- Public ownership of wildlife



### History of Wildlife Laws

#### 1861 First game law in Texas 2 year closed season for northern bobwhites on Galveston Island

- **1879** Texas enacts general game laws
- **1880** 130 counties claim exemption from game laws
- **1895** Fish & Oyster Commission established in Texas
- **1900** Lacey Act prohibits interstate transfer of wildlife

## **History of Wildlife Laws**

- Passage of Migratory Bird Treaty Act, United States and Canada. \*amended in 1918
- Legislature turns over entire game fund to the department.
- **1962** 129 counties under full or partial regulatory authority
- Texas Game & Fish Commission renamed TPWD
- 233 counties under full/partial regulatory authority
- Endangered Species Act adopted Clean Air Act & Clean Water Act

## Who funds wildlife management?

- **Pittman-Robertson Act (~\$51 million)** excise tax on firearms & ammunitions. 11% on long gun and ammo, 10% on handgun
- **Dingell-Johnson Act (~\$20 million)** excise tax on fishing tackle and boat motor fuels
- State matches PR and DJ at 25%
- Sale of State Hunting & Fishing licenses (\$1-2 million)



#### Legal status of Master Naturalists

-same as public

#### Sense of Entitlement

## **Issues: Collecting Birds**

§ 64.002. PROTECTION OF NONGAME BIRDS. (a) Except as provided by this code, no person may:

- catch, kill, injure, pursue, or possess, dead or alive, or purchase, sell, expose for sale, transport, ship, or receive or deliver for transportation, a bird that is not a game bird;
- (2) possess any part of the plumage, skin, or body of a bird that is not a game bird; or
- (3) disturb or destroy the eggs, nest, or young of a bird that is not a game bird.

#### Issues: Nests & Birds

§ 64.003. DESTROYING NESTS OR EGGS. No person may destroy or take the nest, eggs, or young of any wild game bird, wild bird, or wild fowl protected by this code except as provided in this code.

§ 64.007. POSSESSION OF LIVE GAME BIRDS. No person may possess a live game bird in this state except as authorized by this code.

## **Exceptions: Non-Native & Exotic**

- House Sparrow
- European Starling
- Pigeon







#### **Exceptions: Education Provision**

Provisions exist to possess wildlife and wildlife parts for the purpose of education. These materials require a letter from a person with a collection permit

acting within the scope of his or her authority may take, transport, release, and manage any of the wildlife and fish in this state for investigation, propagation, distribution, education, or scientific purposes. All specimens collected under this authorization remain the property of the people of this state. This authorization is valid only for the duration of the employee's tenure with the Department or until rescinded by the Department. This authorization is issued subject to the provisions on the reverse side.

#### **Exceptions: Rehab Provision**

Provisions exist to possess wildlife for rehabilitation by a licensed/permitted rehabilitator. Possession is allowed for transportation.
