Our May program will be on *Roles and Responsibilities of Texas Cooperative Extension Agents* by **Roy Walston**. Mr. Walston will discuss the organizational structure and roles volunteers play in identifying issues, planning, and conducting educational programs in the areas of agriculture and natural resources, family and consumer sciences, and 4-H and youth development in Kerr County.

Mr. Walston currently serves as Kerr County's Extension Agent and is responsible for Agricultural and Natural Resources educational programming for Texas Cooperative Extension. He has served as a County Extension Agent for 18 years with assignments in Wise, Hall, San Saba, Crockett, and Kerr Counties.

Walston was recognized by his peers on a state level as Outstanding New Agent in 1987 and has received numerous commendation awards in the areas of mass media, as well as livestock and crop marketing. He received a Bachelor of Science degree from Angelo State University and a Master of Science degree from Tarleton State University.

This meeting will be held on Monday, **May 22**, at 7:00pm at Riverside Nature Center, 150 Francisco Lemos Street in Kerrville, with our social beginning at 6:30pm. We hope that you can join us.

Texas Hill Country Bats

Texas is home to more bats and bat species than any other state, and Central Texas hosts many millions of these flying mammals from spring to fall, sometimes as late as Thanksgiving. Here in the Hill Country, we are fortunate to have a number of caves, tunnels and bridges where we can view bat emergences. In most cases the bats emerge around dusk, so you should plan to arrive about an hour before sunset in most cases.

Here are some of the bat colonies in our area which are open to the public for emergences:

- Old Tunnel Wildlife Management Area Kendall County between Fredericksburg and Comfort, on the Old San Antonio Road, 2–3 million Mexican free-tailed and cave myotis bats. Call 866 978 2287 for current emergence time and details.
- Eckert James River Bat Cave near Mason. Six million Mexican free-tailed bats. Contact the Texas Nature Conservancy at 512 224 8774 for more information.
- Devil's Sinkhole State Natural Area near Rocksprings. Tours Wednesday through Sunday by reservation. Call 830 683 2287 or visit www.devilssinkholetx.com.
- **Bracken Cave** north of San Antonio. 20–40 million Mexican free-tailed bats. Owned and managed by Bat Conservation International; currently open to groups (such as Old Tunnel volunteers and Bat Conservation International members) by special arrangement.
- **Congress Avenue Bridge –** downtown Austin, Town Lake. Largest urban bat colony in the world 1.5 million Mexican free-tailed bats.

The emergences can be spectacular whether viewed from a distance or up close. And for a truly unique experience, you can visit Old Tunnel at dawn and see/hear the bats returning to their home.

A Page from the Herbarium

This month's plant: Dutchman's Breeches

Scientific name: *Thamnosma texana* Family: *Rutaceae* (Citrus Family)

This low, sprawling, loose clumpy plant is found in pastures and open grassy areas and on rocky slopes. **Dutchman's Breeches** is $6^{\circ} - 12^{\circ}$ (to 30 cm) tall; the stems are somewhat wiry. Its leaves are simple, $1/4^{\circ} - 3/8^{\circ}$ (5 - 15 mm) long and in an alternate pattern. The small, urn-shaped flowers are yellow (purplish-red in the form *purpurea*) and have four petals and four sepals. The common name refers to the shape of the fruit, which is inflated and in the shape of a pair of pantaloons. Crushed or bruised plants produce a strong lemony odor.

Dutchman's Breeches is one of several larval plants used by the Eastern Black Swallowtail butterfly. It is toxic to some livestock. For more information on its toxicity, see http://texnat.tamu.edu/cmplants/toxic/plants/dutchmansbreeches.html.

Locally, specimens can be viewed in both the Riverside Nature Center meadow and the Butterfly Garden at Kerrville-Schreiner City Park.
