


Annual meeting last week





- Overview of Sept Bank Statement
- Review of current status:
 - o Projected Income in 1/2020 = 3,975.00; 2,475.00 & 1,500.00 respectively
 - actual income = 2,931.00 Total Paid \$1,106.00 \$ 1825.00 respectively
 - Covid reduced expenditures
 - Group tour not done eliminating expenditure of 575.00
 - State meeting virtual reducing registration to 55.00 (4 scholarships for 220.00) rather than 5 as planned
 - Intern class virtual with increase in time for completion; name tags will be provided in 2021 rather than 2020: 250.00 unspent this year.
 - Committee's fairly inactive no request for funds.
 - Geological Society paid for Zoom account
 - No requests for Youth Support; 300.00 in account
 - Op. Exp. Reduction due to all of the above and donation of materials used
- Approximate dollar amount of funds not used = 2,200
- At this point in time we have 4,121.82 in our checking account at Navy/Army Credit Union.
- Approximately 2,000.00 comes from previous years beginning in 2008 first records available

Question related to reduction of income because we are non-profit

"Nonprofit," generally means we have successfully jumped through the proper state and federal hoops to receive the most favored, section 501(c)(3), tax-exempt status. It doesn't mean we have to spend every dollar taken in.

A nonprofit can make a profit. Though a nonprofit is not CREATED for a profit-making purpose, it is allowed to make profits along the way to fund its good works.

A nonprofit's purposes MUST be "public or charitable" rather than profit-centered for the benefit of private individuals. If we have the good fortune to collect more in donations than is needed in a particular year to cover expenses, that's good.

Federal Tax Law

Because we are a 501(c)(3), we had to complete IRS forms and pay fees first, then send the IRS documents to the Texas Comptroller's Office to demonstrate federal and state 501(c)(3) status. We demonstrated that we are formed for nonprofit purposes under federal law, thus under state law. Where our monies come from and what our mission is identifies us as being a 'charitable' organization; not for the benefit of private interests.

That doesn't mean though, that a nonprofit can never have a surplus of funds. It can receive grants and donations, and can have activities that generate income, so long as these dollars eventually are used for the group's tax-exempt purposes. If there is money left over at the end of a year, it can be set-aside as a reserve to cover expenses in the next year or beyond.

Spending Down all Income is Fiscally Irresponsible

Maintaining a financial cushion is good money-management and it's legal.

How can we lose our 501(c)(3) status?

- Private benefit/inurement,
- Lobbying,
- Political activity
- Excessive unrelated business income (UBI) and
- Not filing income tax for three years
