Nature Notes - Quintana Beach Fish Kill

Patty Brinkmeyer, one of our Chapter members and the Manager of Quintana Beach County Park, presented her 6/09 observations of the recent "fish kill" at the pedestrian park with hard head catfish and others floating offshore. She alerted the Texas Parks and Wildlife Kills and Spills Team, then proceeded down the beach with another employee, Krissy, finding higher concentrations of fish, predominately Gulf Menhaden, including a shark and stingrays at Bryan Beach. Driving farther down the beach, they found a "long mat of floating dead fish", "thousands of fish rolling in the surf as far as we (they) could see". She shared photos and live video footage of their sightings. Texas Parks and Wildlife (TPW) confirmed the event was caused by low concentrations of dissolved oxygen, a "natural occurrence" resulting from weather, water temperature and other conditions that worked together to reduce dissolved oxygen levels in the water required by aquatic life to breathe. The dead fish were removed in a 3-day operation by TPW workers using front end loaders and buried in the sand dunes.

Jimmy Salinas talked about having seen dead fish along the shoreline and having noticed more dead fish as he got closer to the mouth of the Brazos River.





Featured Speaker – Jimmy Salinas introduced **Lance Wood**, Science and Operations Officer at the National Weather Service in League City; Graduate of Texas A&M University where he received both a Bachelors and Master's Degree in Meteorology.



"The 2023 Hurricane Season: What You Need to Know". Some of the highlights included the following:

- The Atlantic Hurricane Season extends from June 1 through November 30 of each year, with the season peak in August/September due to continued warming of the water.
- The 2023 season forecast includes 13 named storms, 6 hurricanes and 2 major hurricanes.
- Two (2) competing factors are El Niño (negative) and above normal sea surface temperatures (positive).
- Galveston has a 1:9 chance of a hurricane, with a 1:25 chance for a major hurricane tracking within 50 miles every year. Hurricane Alicia in 1983 was the last major hurricane in our area.
- Hurricane warnings are issued just for winds.
- The Saffir-Simpson Hurricane Wind Scale uses a 1 to 5 rating scale to classify a hurricane based upon its
 maximum sustained wind speed. Those rated Category 3 or higher are considered major hurricanes, with
 the potential for greater property damage and loss of life. The scale does not consider other factors, such
 as rainfall amounts, flooding, tornadoes or storm surge, all of which can cause considerable damage.
- Water-related hazards cause approximately 90% of fatalities. Indirect causes of death include stress/strain, carbon monoxide poisoning from poorly ventilated generators, fires from open flames, power outages affecting medical equipment, falls and accidents.

Brian Frazier, Director of the County Parks with Texas Parks and Wildlife, addressed the meeting to further explain the fish kill at Quintana and answered questions. He described it as the result of "a perfect storm" where conditions came together to drop the dissolved oxygen levels in the water.
