Amanda graduated intern training with the South Texas TMN Chapter in Corpus Christi in 2017, having been a volunteer at the Padre Island National Seashore Turtle Lab. She continued her work with the endangered Sea Turtles. When New Year's 2018 brought a "Big Freeze" to the area, she prepared patrol vehicles to rescue cold-stunned turtles, then reported to Packery Channel and began a walking patrol. She had nearly given up when she spotted and rescued the first of several thousand cold-stunned turtles! Amanda worked tirelessly to save the precious turtles and ensured data and photos of each turtle were properly and accurately collected. Later, she was one of two people who entered the vast collection of data into computers.

Amanda currently lives in Brazoria and works for the Brazoria County Parks Department. She continues to perform beach patrols for nesting turtles and is available for possible cold-stun events. She's also the key field researcher on the "Comprehensive Survey of Spiders of Brazoria, Nueces and Kleberg Counties". Although she hates direct contact with the webs and the spiders, she takes incredible photos, captures minute specimens and enters volumes of data into i-Naturalist!

Featured Speaker - Cris Tobola is an Associate Professor of Biology at Brazosport College. After earning a Master's Degree in Biology, her passion for nature and life led her into teaching science in 2017. She moved to our area from Northern California in June 2022. Cris started attending meetings and volunteering with Master Naturalists almost immediately and became a certified member in June 2023. Balancing work, family and outreach events keeps this nature loving individual busy. Community involvement and education are her passions along with enjoying what nature has to offer.

The following are some highlights of her presentation:

- · Ecology is the scientific study of organisms and their surroundings relationships between organisms , as well as between organisms and their environment.
- Urban ecology is the study of humans in cities, of nature in cities, and the coupled relationship between humans and natural systems. It is a multidisciplinary topic of research studies complex interactions between humans and their surroundings.
- Urban ecology promotes resilient and sustainable urban spaces where humans and nature coexist.
- · Urbanization is the process by which towns and cities are formed and grow larger as more people begin living and working in central areas. It leads to a disconnect from nature.
- Natural ecosystems are defined as any habitat without human interference. These tend to be complex, highly diverse and highly stable. Examples include the San Bernard National Wildlife Refuge and the Brazoria National Wildlife Refuge
- · Negative effects of urbanization include air and water pollution, hydrologic changes, local climate change and soil changes and movement.
- Urbanized areas create "heat islands' as they experience higher temperatures than outlying areas, Buildings, roads and other infrastructure absorb and re-emit the sun's heat more than natural landscapes such as forests and water bodies. Houston is #2 on the list for number of people living in heat islands.
- Ecosystems are disrupted by urbanization.
- The natural food web becomes the urban food web.
- · Urban planning provides for green spaces with government planning and management. Local organizations focus on educating the community to preserve natural areas. The "Leave No Trace" campaign provides information people can use to enjoy and care for the natural outdoor spaces and parks they visit.
